### **Old Business:**

**Motion** by Pontinen, seconded by Heitzman to approve Graves drilling proposal of \$14,350 for cleaning the screen on well #5. It's been 20 years since the screen was cleaned. MCU

**Motion** by Heitzman, seconded by Pontinen to approve Little Falls Machine to rebuild a snowplow with new springs. MCU

**Motion** by Heitzman, seconded by Pontinen to approve hiring Wright Tree Removal. This company has been used by the city before. MCU

**Motion** by Heitzman, seconded Pontinen to have Interim Clerk Skrbich move forward with setting up an interview for the one applicant for the Wastewater Treatment Plant. MCU

**Motion** by Heitzman, seconded Pontinen to approve the County Land sale and for Interim Clerk Skrbich to keep an eye on it and bid when necessary. MCU

### **Miscellaneous Announcements:**

Mayor Smith spoke with Paul Peltier, Director of RAMS. RAMS lobbies to help small cities with grants. The city will look at getting a housing study done.
