Reports - Mayor & Council

Councilor Pontinen: Would like to check into the Police Department to see if Gilbert should go alone or try to merge with Eveleth and discontinue the service with Biwabik, to make sure Gilbert is not overpaying for services. He would like to look at cost savings of merging, if any; if Biwabik is getting charged the right amount, etc. Mayor Oberstar OK'd having a couple council members look into it. Clerk Skrbich suggested adding it as an Agenda item for the next meeting. Councilor Vertachnik and Councilor Skrbec supported the idea of looking into it.

Councilor Skrbec: Suggested having a formal discussion and a process for looking into the intown ATV routes. The current ATV map is from 1985 and since the City has changed greatly, including the addition of the Off-Road-Vehicle park and plenty of tourists coming through. Many towns do allow for in-town driving, Gilbert does not. Skrbec suggested getting together with Police Chief Techar and getting things updated, with an end goal of a new map. Mayor Oberstar OK'd getting a committee going by the next meeting.

Councilor Horne: Concerns of the third-party vendor, PSN, the City uses for utility payments. Clerk Skrbich agreed there have been problems with the system and stated he has a proposal to switch to Caselle, our software company. Skrbich explained the hold on switching last year was due to not having the Utility Billing Clerk in a permanent position at that time. It is now, and he agreed it is time to revisit what needs to be done to switch from PSN to Caselle.

Councilor Vertachnik: Joined the Council to help the City, by looking at budgets and try to help get improvements for the City. Vertachnik would also like to help try to get more volunteers.

Mayor Oberstar: Oberstar stated it is not true that Gilbert is the highest taxed City and expressed concern in stopping the decline in the population. Mayor Oberstar would like to see more mining, more people and more businesses to help boost the economy. He explained that property taxes do not pay everything that is needed to run the town. Mayor Oberstar stated he's here to be proactive and help the community. He would like to re-visit the options for the school property and mentioned development ideas.

Police Chief Ty Techar: Receiving snow plowing complaints, many using ATV's that don't have the strength of a MNDOT plow.
