Reports - Mayor & Council

Councilor Vertachnik: Nothing at this time.

Councilor Horne: Nothing at this time.

Councilor Pontinen: Appreciative for the new dental building and for Mark Peterson's building. Would like to see the City step up to visually improve Main Street and buildings the City owns. Mayor Oberstar agreed and stated it's in the budget to get that work done. Clerk Skrbich stated that this is also the purpose of the of "work orders" to track projects and have a visual reminder of priorities etc., of things that need to be done within the City.

Councilor Skrbec: Regarding the Trail discussion, will connect with Ty to look into the traffic concerns that are coming up. Possibly reducing speed limits on city streets and looking at potential solutions to encourage people to obey the trail system.

City Clerk Mike Skrbich: Initial budget meeting set for next week.

Motion made by Counselor Skrbec, supported by Horne to hold a Special Working Session for budget talks on Tuesday, September 2nd, 2025 at 6pm in the Council Chambers. MCU Counselor Pontinen reminded the public these meetings are open to the public to attend.

Motion made by Counselor Skrbec, supported by Pontinen to instruct the Attorney and City Clerk to drop language for an agreement between Mesabi Mountain Trail and the Northern Minnesota Jeepers, as well as, tabling the formal vote until August 26th to extend the public comment period for anyone who wants to write to the Clerk, and the Council will have an opportunity to review. Roll call vote: 5 to 0 in favor of this motion.

Motion by Vertachnik, seconded by Horne to approve a building permit for Leo Skrbec. Counselor Paul Skrbec abstained from the vote. Motion carries 4 to 1; with one abstained. MCU

Motion by Vertachnik, seconded by Mayor Oberstar to deny a building permit for Kayla Knutson. Property is not zoned for what Knutson is looking for. MCU

Motion by Vertachnik, seconded by Mayor Oberstar to deny a fence application for Steve Brandt. Property is not zoned for what Brandt is looking for. MCU

Motion by Skrbec, seconded by Vertachnik to approve C&C Winger concrete replacement for \$12,750. MCU

Motion by Skrbec, seconded by Horne to adopt Resolution 20-13, in support of Mesabi Mountain Trailhead and for the purpose of discussion and allow public comment and council commentary.

Police Chief Ty Techar spoke on various stats, primarily on ATV's.
