**Public Participation**: Jamie Gardner from East Mesabi Sanitation let the City Council know that he did respond to the RFP and submitted a proposal by August 29<sup>th</sup>.

Joseph Pulles, former council member for 6 years, representing support for the Gilbert Police Department and Gilbert Fire Department. Pulles asked the city council if it is true what he is hearing about the police department being demolished. Mayor Oberstar, Jr. stated it was not true, and they are looking at partnerships, not abolishment.

Councilor Pontinen stated he asked the council if Counselor Vertachnik and himself could look into seeing if there were different ways to police Gilbert. They looked at various options to see if we can afford what we are doing now or save money to go elsewhere. Pontinen reiterated that it was never to abolish the police department.

Councilor Skrbec stated there are current problems in the police contract and believes the best path forward is to get more revenue from Biwabik so that they are paying for their fair share. Skrbec believes this is the best model for the City right now as it has been working for a long time with the exception of Gilbert citizens having to pay the burden for coverage in Biwabik. Skrbec would not favor other potential solutions at this time.

Councilor Vertachnik stated he doesn't think they will ever abolish the Gilbert police department. Pulles inquired if they are abolishing the Gilbert Fire Department to which Vertachnik responded that it was looked into to combine with other entities and there is always a cost involved in everything we do therefore they are looking at all costs and how the City can save money.

Clerk Skrbich reminded everyone that overall, as they look at the budget and everything that they are doing, they have to consider the costs of everybody involved and it's premature to say anything about what your absolute future plans are until you get them budgeted into the system and know what it's going to cost the city.

Gilbert resident Tamara Gulbranson inquired about the City of Biwabik's estimate for police services that were sent to the City of Gilbert. Clerk Skrbich stated they had just received the estimate back from Biwabik with numbers that do not agree with what their initial discussion was, therefore, the council will have to look long and hard at it and evaluate the offer and see if it fits in with that Gilbert's budgeted figures are for Gilbert's Police Department. He continued stating whether somebody wants to pay their share or not is a whole other issue, but at the current time, it's not where it needs to be. No decisions will be made this evening. More discussion took place on coverage between the towns and concerns were voiced.

**Police Chief Ty Techar:** There have been 4 arrests in the last 3 weeks for thefts from vehicles and garages. Still trying to recover some stolen property. A search warrant was executed recently on New Jersy Ave., some stolen property was recovered. Techar gave an update on blight.
